

This Agreement is by and between the
SANTA BARBARA VOLLEYBALL CLUB, hereinafter "**Club**," and

hereinafter jointly as "**Club Player**."

Whereas, Club is a nonprofit corporation operated under control and direction of its Board of Directors and Director; and
 Whereas, Club is co-sponsored by the Santa Barbara City Parks and Recreation Department; and
 Whereas, Club provides a volleyball program including training, coaching, and participation in club volleyball tournaments; and
 Whereas, Club is financed by a combination of grants, donations of time and money, player fees, and club activities; and
 Whereas, Club Player wants to participate in the club volleyball program for the 2007 season; and
 Whereas, Club policy is to provide a quality, competitive club to improve skills of club players in a positive atmosphere;

Now therefore the parties agree as follows:

I. FEES. (A) Regular fees: The basic budget of the Club includes the seasonal cost of rental of facilities, association memberships, coaches' salaries, overhead and administration. The cost per player is based upon the number of players who commit to play on each team. *As a result, the fees must be paid to the Club even if Club Player elects to cease participation in the Club at any time.*

Club Travel Team Player agrees to timely pay FOUR (4) equal payments (see table) on or before:
(1) December 1, 2006 (2) January 1, 2007 (3) February 1, 2007 (4) March 1, 2007.

The Blenders Player agrees to timely pay in full on or before **February 1, 2007.**

The fees do not include medical insurance for Club players. Limited medical insurance is only available by registration in the United States Volleyball Association. Each Club Player must execute the Club's Liability Waiver and Medical Release.

(B) Additional Costs (Traveling Teams Only): The above fees and costs are based upon a schedule of tournaments that does *not* include optional tournaments or post-season play. The fees include food and lodging expenses to regular SCVA *overnight* tournaments for teams only. Some changes in the regular team schedule may increase or decrease the costs. A team may elect to attend additional tournaments and/or post-season play, and the costs and payments for those tournaments will be handled by the team.

II. CLUB PARTICIPATION. Club Player agrees to:

- (a) Attend all scheduled practices and tournaments unless otherwise arranged in advance;
- (b) Maintain good academic standing the entire school year;
- (c) Maintain good sportsmanship at all times;
- (d) Be respectful to players, coaches, and Club personnel;
- (e) Comply with Club policies and regulations as issued and amended by the Board and Club Directors;
- (f) Inform Club of all changes in address, insurance coverage, and emergency contacts.

III. CLUB ADMINISTRATION. Club's volleyball program is competitive and seeks to treat all persons in an equitable manner in accordance with its adopted Mission Statement. It is not uncommon for persons to disagree with coaching decisions or Board decisions. The Club Player has the right and obligation to bring to the attention of the Club Directors, coaches and the Board, as appropriate, concerns, questions, or suggestions. However, it is agreed and understood that the actions and decisions by the Board and the Club Directors upon consideration of the concerns, questions or suggestions, are not subject to further review.
